FORMPAK NEWS

Happy New Year! Formpak was founded in 1982, which means we our now entering its fourth different decade, second different century and second different millennia (not bad for a software company!). After our biggest year for team growth in 2019, we are ready and excited for an incredibly busy 2020!

As mentioned in our October Newsletter, we expanded both our Support and Development Teams last year. Over the past 12 months we've also been delighted by the success and growth of our customers too! This has lead to a record number of upgrades to Formpak Licenses and a surge in demand for system updates.

We have also seen the software being used to a greater depth and complexity. This is evident in the number of requests for custom documents. Many of which feature sophisticated functionality with new logic required to facilitate it. Our training days also had a higher attendance in 2019, with a keen interest in many of the advanced areas of Formpak.

SECURITY ENHANCEMENTS

To help maintain a secure environment for our customers, we have introduced the following enhancements:

Additional Password Criteria

All new passwords will need to contain at least:

- 8 characters
- 1 number
- 1 uppercase
- 1 lowercase
- 1 special character

Please note that existing passwords will remain valid.

Locking Failed Login Attempts

This feature has configurable options for; the number of failed login attempts, the duration of the failed login period and the duration of the lockout period.

Please note that this feature will not take effect until the options are configured in 'Manage Application Settings'.



SECURITY ENHANCEMENTS CONTINUED...

Captcha

This adds an extra layer of security when signing into Formpak. This feature can be activated in 'Manage Application Settings'.

'https' Security Headers

Formpak is now configured to enable the use of https URLs. However customers will need a relevant https security certificate before this can be utilised.

These new features are already available from version 37241 onwards. If you would like to schedule a system update to start using these features please contact us.

IFRA 49th AMENDMENT

The 49th Amendment to IFRA has been issued, officially dated 10th January 2020.

Formpak has implemented these amendments by introducing a new group of properties and new IFRA Certificates. The IFRA 49th Amendment is a different scheme to 48th and prior, and therefore they are independent of each other. We anticipate customers will have both schemes running on their systems for a period of time, so results can be compared between each scheme and also to allow time for additional data to be gathered on essential oils and third party mixtures.

IFRA / IOFI LABELLING MANUAL 2019

The latest version of the IFRA / IOFI Labelling Manual was formally released this month. We have been preparing a new set of Labelling Manual reference data for this release and hope to have it ready soon. Once completed, the data will be available on request. 
Formpak login screen with new Captcha security field

We will continue to upload new support articles, making the Support Centre an excellent resource for walkthrough guides, useful articles, downloads and links to YouTube videos.


Formpak Website
