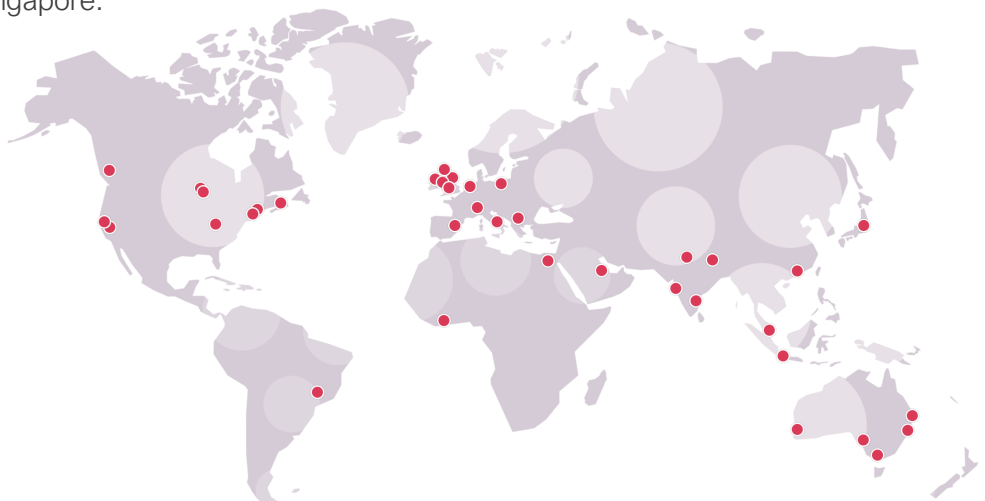
CELEBRATING

CHANGES TO CLP AND GHS SAFETY DATA SHEETS

This year, we have updated the CLP Safety Data Sheet by adding the capability to allow UFI's to be added to the Cross Reference. There have been changes to Section 8 to incorporate translations, an update to Section 3 to display REACH numbers for PBT ingredients, more flexibility in the First Aid Section 4 and splitting the transport information in Section 14 to display separate transport modes with translations for item names.

From last year, the GHS Safety Data Sheet was more closely aligned with the CLP SDS. This year, the GHS SDS has had a similar transport amendment in Section 14 with the modes displayed separately and translations for transport item names has been implemented. Various EC and REACH references have been removed.

WORKPLACE HEALTH & SAFETY / COSHH DOCUMENTS

Recently we have noticed a growing number of requests for custom COSHH (Workplace Health and Safety) documents. The documents can include information about the hazard presented by an ingredient, the frequency and volume of use, plus safe handling requirements. Appropriate information can additionally be used on labels and manufacturing documentation.

Manually completing Workplace Health and Safety Assessments can be very time consuming. By using information already present in Formpak, you will be able to achieve an automated process, quickly generating the assessments at the click of a button, contributing to ongoing safety of your staff and saving time and money in the process.

Collaborating with you, we can create documents to match an existing template or help you create one from scratch. We will offer our regulatory expertise to ensure the relevant requirements are met.

NEW & UPCOMING FEATURES

Shortcut Keys in the CDT - This is a small update but one of our favorites. We have recently added some shortcut keys to the CDT allowing you to quickly access tools from the 'Other Menu' drop down. Upcoming Features: Notifications for Projects and Tasks will allow users to receive alerts for Projects and Tasks, when there is a change in status, helping you to work more efficiently. We are also working on a new function for formulators called 'Round', so you can target a group of ingredients to round the concentrations to a specified number of decimal places, very useful after using 'explode'!
